ANSWER ANY FIVE (5) OF THE FOLLOWING QUESTIONS ONLY (5 x 20 marks = 100 marks)

1. Opposition leader of Uttar Bhumi state, Pratap Kumar Yadav alleged that the Chief Minister Ashok Kumar Singh has been hand in glove with smugglers and because of that the state became heaven of smugglers. The Chief Minister ordered public prosecutor to prosecute Pratap Kumar Yadav. Examine whether the leader of opposition has any defence available among ten exceptions to criminal definition of defamation, and explain those exceptions.
2. A Tamil tabloid weekly notified publishing a serial of autobiography of Sankar sent to editor by him, exposing the unscrupulous links between police and criminals. The Home department prohibited weekly from publishing that serial claiming the autobiography of death convict is part of his privacy, and that it was state property as he was in prison, Government has to protect it. Police Officers Association claimed that the serial should be stopped because it is going to tarnish the image of the police in state.
 - a) Discuss whether publication of autobiography is invasion of privacy of the author or that of Home department?
 - b) Discuss whether the news magazine can be prevented from publication on the ground of possible defamation?
3. What is the significance of *New York Times Rule* on defamation of public servant and freedom of press in US?

4. Fair comment expands the freedom of speech and expression. Do you agree with this statement? Justify your stand with relevant case law.
5. An MP belonging to opposition party has used derogatory language against the Speaker of Lok Sabha attributing bias. 'The Herald' newspaper reported the verbatim abuses on the front page under sensational caption "Speaker's Bias Exposed". 'The Voice' newspaper filed an investigation report exposing a conspiracy between MP and 'The Herald' newspaper to defame Speaker, through parliamentary speech and avail the immunity. The Speaker filed a criminal case of defamation against both MP and the newspaper 'The Herald'. Discuss the liability of MP and newspaper with reference to privileges of Parliament under the Constitution of India.
